Activities Agreement - Introduction: Township District 214 High Schools believe that it is the function of the Activities Department to provide activities which are interesting, wholesome, stimulating and enjoyable for all students. The overall objectives are to develop activity understanding, sportsmanship and a spirit of competition in each boy and girl.

Agreement: To insure the proper atmosphere for excellence, the student and his/her parents or guardians must understand and cooperate in helping establish that condition by adhering to all school rules and regulations. When a violation of school rules occurs, proper steps will be taken. A student may be suspended or dropped from an activity for the remainder of the season for violating any of the following standards: (1) falsification of parent's or guardian's signature on activities permit; (2) use of, possession of, or distribution of alcohol or tobacco; misuse of nonprescription drugs, or of controlled substances; (3) theft or destruction to property of any school or individual; (4) repeated acts of unsportsmanlike conduct; (5) failure to follow training rules as set forth for individual activities by coaches and approved by the Assistant Principal of Student Activities. All students are subject to the provisions as described in the District 214 Co-Curricular Code, which can be found in the student handbook. This code is in effect 24 hours per day, 7 days per week.

Eligibility: A student must have his/her parent or guardian's permission to participate. The student is required to abide by the IHSA bylaws on eligibility. A copy can be obtained from the Activities Office, and also in the student handbook. Prominent among these bylaws is the scholastic standing requirement that states every student must be passing 20 credit hours of high school work per week, must have passed 20 credit hours the previous semester, and the student must be living with the legal guardian.

Informed Consent: We realize that such activity involves the potential for injury to our son/daughter that is inherent in all activities. We acknowledge that even with the best coaching, use of the most advanced protective equipment, and strict observance of rules, injuries to our son/daughter are still a possibility. We recognize that on rare occasions these injuries to our son/daughter can be so severe as to result in total disability, paralysis or even death.

Permission to Participate: My son/daughter has my permission to practice and compete in the interscholastic activities listed above and I also approve my son/daughter abiding by all of the conditions of the activities agreement and the IHSA Activities Eligibility Rules.
